Connecticut Athletic Wealth Disparity

Our clinic aims to address the wealth disparity in Connecticut high school sports by providing inner-city youth with equal access to basketball training and resources. The clinic will be held at two locations: Roosevelt Elementary School and Luis Munoz Marin School in Bridgeport, CT, every Monday and Tuesday from February 26th to March 25th and February 27th to March 26th, respectively.

Organized in response to recent findings revealing a significant gap in high school sports championships between affluent and economically disadvantaged towns in Connecticut, the clinic seeks to empower young athletes from underserved communities.
